Net Worth as at 28 December 2024 was £679.7m. Restricted Payments of £14.5m were made in Q1 and £23.2m during the Relevant Year. The Restricted Payment Maximum at 28 December 2024 was £141.6m and no calculation of the Further Restricted Payment Maximum was required.



Maintenance and Capital Enhancement

The cumulative Maintenance Expenditure in the Relevant Year was £22.7m and the Relevant Period was £10.7m. The Required Maintenance Amount for the Relevant Year was £17.6m.

Capital Enhancement Expenditure of £2.9m was made in Q1, £10.0m in the Relevant Year and £4.9m in the Relevant Period.
